GI Clinical Epidemiology: (Weekly Wednesday 0700:). The goal of this conference is to prepare GI fellows to become critical readers of the medical literature and to develop a more sophisticated approach to clinical practice and research. Areas covered during each year have included: descriptive epidemiology, screening, meta-analysis, decision and cost analysis, quality of life assessment, study design, evaluation of diagnostic tests, and information management. (Started in 1994)
